

(Maharashtra)
2. I say that I am fully aware I have been provisionally selected to the Maharashtra Institute of Physiotherapy, Latur for **Bachelor of Physiotherapy** UG Course through **85% State Quota/ 15%NRI/ Against NRI Quota** under **OPEN/ EWS/ SEBC/ OBC/ VJ-DT/ NT-1/ NT-2/ NT-3/ SC/ ST Category** for the academic year 2024-25 & I am also given instruction by the college that my admission will be finally Granted by DMER, Mumbai, Admission Regulating Authority, Mumbai & Maharashtra University of Health Sciences, Nashik. If any office raise query in admission of my candidate, their Documents & Other requirement. I am liable to clear or submit necessary information to College & concern offices.
3. I say that at the time of securing my First year admission I have paid a sum of Rs. \_\_\_\_\_/- as a Tuition and Development fees for BPTH Course and I will paid same fees for next Three Year (II Year, III Year, IV Year).
4. I say that I am fully aware that the aforesaid fees paid by me are subject to revision at any time. In the event of the fees being increased by the appropriate Authority/Judicial Pronouncement, I hereby undertake to pay the difference amount of the fees within a period of 07 days from being notified. I hereby also undertake that I will not challenge the increase in the amount of the fees for any reason whatsoever.
5. I say that I am fully aware that If my EBC/Scholarship/Freeship/ST Claim rejected by SWO/DMER/Tribe Office I will pay full fees at the starting academic each Year.
6. I say that my Family Total income is Rs. \_\_\_\_\_/- & I am submitting Income certificate which is given by competent authority if my income is increased after admission in Next Year or found wrong income certificate above Rs. 8,00,000/- I am liable to pay full fees.
7. I say that I am aware that the repeater (failure) fees will be charged as per the rules and guidelines of the concerned authority.
8. I Say that Maharashtra Institute of Physiotherapy, Latur. have given all information about UG NEET 2024 admission process hence me & my parents agree to take provisional admission 2024-25.





9. If Government revises/ changes in EBC, EWS, SEBC & OBC students resolutions by any chance & if the Government fails to pay the tuition fees etc. within six months period then students should pay college full fees as per Fees Regulating Authority.
10. I hereby undertake that I am liable to provide caste validity certificate at the time of admission. In case of any delay exceeding six months, (as per Government GR) I shall pay all the tuition fees and development fees of the college immediately after six month. I understand that I will be responsible for the consequences of cancellation of my admission. I also understand that in such an event, I will be liable to pay the full fees for the entire four-year program, or any other penalty as per statutory regulating authorities. I acknowledge that I have read and understood the terms and conditions and abide by them.
11. For any reason,
- a) If I am unable to submit Caste Validity Certificate or in case of claim rejection from Government regarding Scholarship & etc., in such situation I am fully aware and capable of paying yearly tuition fees and development fees to college; failing which I am not eligible for admission as well as continuing this course.
- b) In such circumstances, I shall not use court case as instrument to avoid paying yearly tuition fees, development fees to college under the legal case against Government as first party & not disturb the financial funds flow of this private, non-grant college.
12. In case of failure of grants for my tuition fees from Government, I hereby abide to pay tuition fees and development fees to college as approved by Fees Regulating Authority, Mumbai & mean while if my claim gets approved from government, during my course curriculum, then I will ask for refund of my tuition fees from college authority.
